Eligibility to vote at the AGM and to nominate: [27 (2) BCCV Inc Rules] "Every member who was a financial member for not less than three months of the financial year preceding the Annual General Meeting and is currently a financial member shall be entitled to vote at the Annual General Meeting and shall be entitled to nominate or be nominated as an Office Bearer or member of the Committee." (Financial Year ends 30/06/20)

To Vote: A financial member, whose application was approved by Committee. Junior Members (less than 16 years of age) are not entitled to vote, however Family Memberships may be represented by both adult members.

Note: In the case of the President, Vice-President, Secretary and Treasurer positions, the nominee must be a financial member of DOGS Victoria (VCA Inc).
